## **Covid-19 Guidelines For Church Reopening**

As we look to reopen our church building for services, we recognize that we easily fall into the category of dealing with a more high-risk, vulnerable population. This includes people of advanced age, people in highly dense population centers and people in the racial and ethnic categories that are disproportionately affected by the virus

Therefore, currently we recommend that seniors and those with underlying conditions do not attend services on location. We also recommend that children not attend, but continue Sunday School and Children's church via technology until further notice

it is completely understandable that some are frustrated by the need for us to move slowly, intentionally, and prayerfully back into some kind of regular, in-person routine. Still, we must keep in mind that we have a theological mandate to care for one another holistically in body, mind, and spirit.

The Apostle Paul words to the church in Galatia "Bear ye one another's burdens, and so fulfil the law of Christ." seems fitting in this season. It behooves those who choose to attend services to not judge or be critical of those who choose to continue participating via technology. Thus, fulfilling the law of Christ which is to love one another

To avoid violation of the regulatory capacity, all attendees including children must pre-register at our website. If you do not have access to the website or are unable to manage, please contact your bandleader for assistance with signing up for church. Please do not bring visitors if you have not pre-registered them

The following is the procedure that all who will attend the service in the building will be asked to follow. These recommendations are based on the New York State Religious Services Guidelines (also attached here).

Your cooperation and patience are highly appreciated

## Masks and social distancing are Required

Both the main front door and the side door will be in use and these signs will be posted. Anyone who cannot for health reason wear mask will not be allowed to worship in the main sanctuary but asked to sit in a separate area downstairs and view the service by monitor. Per the guidelines, face mask can be removed while seated, but must be worn if speaking or singing or if someone comes within 6 feet of you even in crossing, e.g. when walking to your seat



### Temp check and questionnaire required at both doors

Upon entering the building, everyone must stop and have their temperature checked and short health questionnaire completed. This will of course require that everyone be on time for service with extra time built in for check in.



#### Hand sanitizer stations

There will be hand sanitizer stations throughout the building, and everyone is asked to use the hand sanitizer before entering the sanctuary

#### Seating from both the main door and side entrances

The center aisle will be a one-way entrance to all seating, with signs indicating such. Both those entering from the main door and the side door will be asked to use that aisle to enter their seat while social distancing.

#### **Social Distance Seating**

**Every other pew** will be employed and only **two persons per pew.** Pews not in use will be clearly marked. If you are the first to be seated in the pew, please move the farthest end of the pew so the next person will sit at the other end without crossing over you. Ushers will be on hand to assist

#### Side Aisle are One Way

The side aisle will be one way, with signs indicating such. Use these aisles to return to your seat after offering, to exit to the bathroom, or to leave the building.

#### **Pulpit layout**

Pews have been removed from the pulpit and replaced with seating. Social distance seating is for the Pastor, Associate Pastor, Lady Elect and Moderator as needed. Musicians and music have also been rearranged for social distancing

### Podium use

Only the Speaker of the day will have use of the podium

### Use of microphones

There will be no sharing or passing of microphones. Each person will receive a sanitized microphone and that microphone will be theirs for the day. Microphone will not be placed on stands and user is asked to keep the microphone with them in case of need for a second use during the service. Microphones will have disposable covers to be removed by the user after using

### Worship Team

Worship team singers will consist of 3 people including keyboardist. Spacing will be made for drummer and other musicians as well. Team will use social distance. First pew on the right is reserved for the worship team.

#### Altar layout

Social distance signs will be clearly marked at the altar, when the altar has reached social distancing capacity, please use the center aisle which will also be clearly marked. Mask is required at the altar

#### Worship in giving

Offering envelopes will be given out by ushers upon entering the sanctuary and can be placed in offering baskets as you exit after the service

#### Exiting the sanctuary/church

When the service is dismissed, those in aisle closest to the side door will exit starting from back pew, down the side aisle and out the side door. Those seated in the far aisle will exit starting from the back pew down the side aisle and out through the main door.

## \* If there are people seated on the balcony or in the overflow area, they will leave first.

\*For your additional safety, other sanitary provisions have been put in place such as auto turn on faucets and towel dispensers, that do not require your touching the dispensers

Guidelines for Religious and Funeral Services

Physical Distancing	<ul> <li>For any religious or funeral service, limit the congregant/attendee capacity to:         <ul> <li>In Phase 1 regions, no more than 10 people for any services occurring indoor or outdoor.</li> <li>In Phase 2 and 3 regions, no more than 25% of the maximum occupancy for a particular area for services occurring indoor; or no more than 25 people for services occur outdoor.</li> <li>In Phase 4 regions, no more than 33% of the maximum occupancy for a particular area for services occurring indoor; or no more than 50 people for services occurring outdoor.</li> <li>In Phase 4 regions, no more than 30% of the maximum occupancy for a particular area for services occurring indoor; or no more than 50 people for services occurring outdoor.</li> <li>If separate buildings are available for use, may have multiple groups of 10 in separate buildings at the same time in Phase 1; a maximum occupancy of 25% in separate buildings at the same time in Phase 2 and 3; or a maximum occupancy of 33% in separate buildings at the same time in Phase 4, so long as the buildings have separate entrances and exits designated and groups do not interact.</li> </ul> </li> </ul>	<ul> <li>Limit in-person presence of staff to only those employees/volunteers necessary.</li> <li>Modify the use and/or restrict the number of stations (e.g. podiums) and seating areas, so that staff members, volunteers, and attendees are at least 6 ft. apart in all directions and are not sharing stations or seats without cleaning and disinfection between use, unless all individuals are members of the same household.</li> <li>Hold services outdoors (e.g. services for religious gatherings, graveside-only funerals) and/or provide remote service options (e.g. live streaming, AM/FM broadcast), when possible.</li> <li>Offer advanced sign-ups to manage capacity.</li> <li>Change or remove practices that involve close contact or sharing things among members of different households (e.g. sharing a car or limousine ride between locations, providing food/beverages for attendees before, during, or</li> </ul>
	A distance of at least 6 ft. must be maintained amongst all individuals at all times, unless safety or the core activity requires a shorter distance (e.g. pallbearing) or the individuals are members of the same household. However, any singing activity must provide for a distance between individuals of 12 ft., subject to additional protective measures.	<ul> <li>Hold drive-in services. Ensure attendees remain in the vehicle in which they arrived and that they don't interact physically with clergy, employees, or attendees in other vehicles; vehicles should contain only members of a single household, and cars must be at least 6 ft. apart or use alternate parking spaces.</li> </ul>
	Any time employees, volunteers, and/or attendees must come within 6 ft. of one another (or 12 ft., if singing), they must wear acceptable face coverings, unless they are members of the same household.	<ul> <li>Reduce bi-directional foot traffic by posting signs with arrows in narrow aisles, hallways, or pews.</li> </ul>
	Prohibit the use of small spaces (e.g. elevators, vehicles) by more than one individual at time, unless all individuals are wearing face coverings. If occupied by more than one person, keep occupancy under 50% of maximum capacity.	
	Prohibit holding or shaking hands of members in different households during services or prayers.

Guidelines for Religious and Funeral Services

	Mandatory	<b>Recommended Best Practices</b>
Physical Distancing (cont'd)	Limit activities involving singing (e.g. choir, soloist, cantor, musical ensemble), unless 12 ft. of separation can be provided between individuals or additional distancing or physical barriers can reduce transmission of respiratory droplets.	
Protective Equipment	<ul> <li>Establish designated areas for pickups and deliveries.</li> <li>Provide workers with an acceptable face covering at nocost to the worker and have an adequate supply of coverings in case of replacement.</li> <li>Acceptable face coverings include but are not limited to cloth (e.g. homemade sewn, quick cut, bandana), surgical masks, and face shields.</li> <li>Face coverings are required at all times except while seated, provided all individuals are 6 ft. apart except for immediate household members. Faith leaders, officiants, volunteers, and/or attendees must be prepared to don a face covering if another person unexpectedly comes within 6 ft. (e.g. when walking to seats).</li> <li>Face coverings must be cleaned or replaced after use and may not be shared. Consult the CDC <u>guidance</u> for additional information on cloth face coverings and other types of personal protective equipment (PPE), as well as instructions on use and cleaning.</li> <li>If providing gowns or other garments, ensure they are cleaned and laundered between uses.</li> <li>Train workers on how to don, doff, clean (as applicable), and discard PPE.</li> <li>Limit the sharing of objects (e.g. religious texts, collection plates) as well as the touching of shared surfaces (e.g. pews, instruments, doors, railings); or, require individuals to wear gloves when in contact with shared objects or frequently touched surfaces; or, require individuals to sanitize or wash their hands before and after contact.</li> </ul>	<ul> <li>Place donation plates/boxes in central location with proper distancing protocols in place.</li> <li>Remove religious texts from pews or benches, and encourage congregation to bring their own.</li> <li>If choir/musical ensemble meets enhanced distancing measures, encourage members to launder their own gowns at home and bring their own instruments, where possible.</li> <li>Adapt certain religious practices that traditionally require close contact in order to minimize contact between individuals.</li> <li>Empty fonts or other shared water-related service or ceremonial activities.</li> </ul>

	Mandatory	<b>Recommended Best Practices</b>
Hygiene, Cleaning, and Disinfection	Adhere to hygiene, cleaning, and disinfection requirements from the <u>Centers for Disease Control and</u> <u>Prevention</u> (CDC) and <u>Department of Health</u> (DOH) and maintain cleaning logs on site that document date, time, and scope of cleaning.	
	Provide and maintain hand hygiene stations on site, including handwashing with soap, water, and paper towels, as well as an alcohol-based hand sanitizer containing 60% or more alcohol for areas where handwashing is not feasible. Hand sanitizer must be placed throughout the location.	
	Provide and encourage participants to use cleaning/disinfection supplies before and after use of shared and frequently touched surfaces, followed by hand hygiene.	
	<ul> <li>Ensure distancing rules are adhered to in restrooms by reducing capacity, where feasible.</li> </ul>	
	Regularly clean and disinfect the location or facility and conduct more frequent cleaning and disinfection for high risk areas used by many individuals (e.g. restrooms) and for frequently touched surfaces, using Department of Environmental Conservation (DEC) products identified by the Environmental Protection Agency (EPA) as effective against COVID-19.	
	If cleaning or disinfection products or the act of cleaning and disinfecting causes safety hazards or degrades the material (e.g. religious artifact), put in place hand hygiene stations, supply gloves, and/or limit the number of individuals touching such material.	
	<ul> <li>For funeral-related services, prohibit touching, hugging, or kissing the body of a deceased person who had confirmed or suspected COVID-19, per CDC <u>guidance</u>.</li> </ul>	
	Prohibit shared food or beverages (e.g. self-serve meals and beverages).

Communication	<ul> <li>Affirm you have reviewed and understand the state-issued industry guidelines, and that you will implement them.</li> <li>Post signage throughout the facility to remind individuals to adhere to proper hygiene, social distancing rules, appropriate use of PPE, and cleaning and disinfecting protocols.</li> <li>Conspicuously post completed safety plans on site.</li> </ul>	ns to
Screening	<ul> <li>Implement mandatory health screening assessment (e.g. questionnaire, temperature check) for employees, faith leaders, and volunteers (but not attendees), asking about (1) COVID-19 symptoms in past 14 days, (2) positive COVID-19 test in past 14 days, and/or (3) close contact with confirmed or suspected COVID-19 case in past 14 days. Responses must be reviewed and such review must be documented.</li> <li>A person who screens positive for COVID-19 symptoms must not be allowed to enter the gathering place and must be sent home with instructions to contact their healthcare provider for assessment and testing.</li> <li>If an employee or faith leader tests positive for COVID-19, immediately notify state and local health departments and cooperate with contact tracing efforts, including notification of potential contacts who had regulations.</li> <li>Maintain a list of attendees.</li> <li>Encourage, but do not mandate, attendees to complish contact tracing, if necessar in generation or Exposure" regarding protocols and polic employees seeking to return to work fafter a suspect contact with a person with COVID.</li> </ul>	to vith e PPE, 3 ith ding or o lete a can be can be y. <u>vate</u> ies for ed or had
